## GENERAL CONDITIONS FOR SALE (RELATED TO PRICE LIST NO.SF/HEX/02/2026)

All quotations, purchase orders or requests are subject to the following terms and conditions of sale. Any qualifications to these conditions made by the Buyer will not apply unless expressly accepted in writing by Sundram Fasteners Limited (hereinafter, called as "SFL"). These General Terms and Conditions of Sale shall not be applicable where SFL and Buyer had entered into Product Sale/Purchase/Supply Agreement. In the event of any dispute, ambiguity in interpretation or claim between SFL and the Buyer the Product Sale/Purchase/Supply Agreement and its specific terms shall apply first. To the extent that the individual Product Sale/Purchase/Supply Agreement and its specific terms are silent, the General Terms and Conditions herein shall apply. If the General Terms and Conditions of Sale are silent, the general rules of the governing law shall apply and prevail.

### 1. ORDER AND ACCEPTANCE

All orders placed by the Buyer shall be subject to SFL's acceptance. SFL shall be at liberty to accept or refuse any order in full or in part without assigning any reasons whatsoever. Orders once accepted by SFL shall not be cancelled by the Buyer unless consented to or by SFL in writing. None of these terms and conditions may be added to, modified, superseded or otherwise altered, except by a written instrument signed by an authorized signatory of SFL. SFL's failure to object to any of the terms and conditions which may be contained in any document of Buyer shall not be construed as a waiver of these conditions or as acceptance of any such terms and conditions.

### 2. PRICES AND PAYMENT

- 2.1 Prices prevailing on the date of dispatch of Goods will become applicable irrespective of the fact that Purchase order/delivery order/advance payment for the same been accepted/issued by SFL.
- 2.2 SFL reserves the right to revise the prices of Goods without any further advance notice to the Buyer or without assigning any reasons thereof.
- 2.3 SFL shall not be responsible for costs, charge, expenses, losses etc., if any, incurred by the Buyer.
- 2.4 The Prices are exclusive of GST as applicable on the Goods supplied. SFL shall collect TCS as applicable on the Goods supplied to Buyer.
- 2.5 Any taxes, cess or duties levied by Central, State, Municipal, Local or any other authority, in effect or hereinafter imposed, on the sale, transportation or delivery of the Products delivered hereunder shall be paid by Buyer, and, if directly paid by SFL, reimbursed to SFL by Buyer with retrospective or prospective effect.
- 2.6 The Cheque/Drafts/Pay Orders not accepted unless otherwise specifically agreed in writing. The Cheque/Drafts/Pay orders should be drawn by the Buyer in favour of Sundram Fasteners Limited. SFL shall not be liable to loss or theft of Cheque/Drafts/Pay orders etc., in transit.
- 2.7 Payment terms are net thirty (30) days from the date of the invoice or as mutually agreed in writing.
- 2.8 Any payments not made within due date shall be subject to a late payment charge for the period of delay beyond due date, penal interest at 18 % per annum.
- 2.9 SFL reserves its right to appropriate and adjust any sums due to the Buyer against any dues recoverable from the Buyer including delayed payment charges, if any.
- 2.10 All stipulations as to time of payment of the purchase price of Goods are the essence of the Contract.

### 3. LOSS OR DAMAGE

Unless otherwise agreed, the risk in the Goods shall pass from SFL to the Buyer the moment they are delivered by SFL to the Buyer or to a Carrier or any other party including Warehouse operated/identified for the purpose (whether named by the Buyer or not) including risk associated with any Goods subsequently returned to SFL. SFL accepts no liability for loss or damage to Goods once handed over to the Buyer or Carrier any other party including Warehouse operated/identified for the purpose instructed/chosen by Buyer.

### 4. PACKING AND TRANSPORTATION

- 4.1 Unless otherwise specified by the Buyer, SFL will select the most economical method and route of shipment. In the event that the Buyer is unable or unwilling to take delivery of all or any part of the Goods, SFL shall place them into storage with all costs, including storage, insurance, demurrage, and transportation at the Buyer's expense.
- 4.2 Packing will be in accordance with SFL/Industry standard practice and Prices quoted are for packing in cartons. SFL retains ownership of any re-usable packaging.

### 5. DELIVERY AND ACCEPTANCE

- 5.1 The delivery dates are tentative and no responsibility is accepted by SFL for delay in delivery or failure to deliver as per delivery schedule due to circumstances beyond SFL's control. Delivery/Despatch may be made in one lot or several lots and if made in several lots payment should be made in terms of the payment clause.
- 5.2 Goods supplied shall be deemed to have been supplied as per the Buyer's specifications unless the Buyer, within 48 hours from the receipt of the Goods give SFL a written notice of any claim, that the Goods are not of stated description or specification to enable SFL to investigate and take appropriate action.
- 5.3 SFL will not be responsible for any shortage/damages notices after delivery has been taken by the Buyer and not reported on the back side of "Lorry Receipt" of Transporter.
- 5.4 The Buyer shall provide SFL with the appropriate tax forms/declarations along with payment and shall indemnify SFL against any losses, charges, expenses for non-submissions of the forms.
- 5.5 The Goods shall be dispatched at such times and in such convenient lots and quantities as SFL shall decide. SFL shall be entitled to cancel an order in whole or in part even if it has been partly executed. Each lot dispatched against a single order shall be considered as a separate contract and failure of dispatch of any one lot or of the balance lots shall not violate the contract as to other lots. The order shall be deemed to have been completed on the date of dispatch in respect of the products actually dispatched in part/full.
- 5.6 SFL shall not be responsible for delays in dispatch of the Goods for any reason whatsoever and the conditions of dispatch and delivery timing of the same. SFL shall not be liable to make good the loss, if any suffered by the Buyer for delay in dispatch or delivery of the Goods.
- 5.7 If the Buyer failed to take delivery of the Goods at the rate, date and time specified herein when the delivery becomes due, then SFL will have the option to cancel the delivery and to claim damages, if any.
- 5.8 Claims by Buyer for shortages or errors in delivery must be made within five (5) days after the delivery of the Goods. Goods are sold subject to the standard manufacturing practices of SFL. Goods purchased on the basis of weight are subject to customary quantity variations recognized by practice in the industry.
- 5.9 If Buyer requests deferral of deliveries, SFL's agreement to defer delivery shall not excuse Buyer from its obligation to pay for the Goods at the same times and in the same quantities as the original delivery schedule, including interest due pursuant to these terms and conditions. In addition to adhering to the original payment schedule, Buyer shall pay such storage charges as SFL may assess for storing the Goods awaiting delivery. If Buyer requests deferral prior to commencement of production, SFL may require progress payments in connection with expenses for materials and services incurred by SFL in anticipation of production.
- 5.10 In no case shall delay or non-delivery of the whole or part of the order be a valid ground for the Buyer to reject or withhold payment for the Goods.

### 6. WARRANTY

- 6.1 All Goods sold subject to the conditions that SFL's liabilities are limited to the replacement of Goods proved to have been defective in material and/or workmanship, when they are sent back to SFL, but SFL will not be responsible for failure of Goods supplied which have been subject to improper use and/or any process or processes.
- 6.2 SFL accepts no responsibility for any contingent or resulting liabilities or loss arising through any defective Goods.
- 6.3 Any claim for replacement will arise only if the Goods are returned within 30 days from the date of Supply.



- 6.4 All other warranties, express or implied, including but not limited to the implied warranties of merchantability and fitness for a particular purpose, are hereby disclaimed.
- 6.5 Any claims for failure of Goods to conform to specifications, shortages, or any other cause shall be deemed waived and released by Buyer unless such claim is made in writing within thirty (30) days from the date of receipt of Goods.
- 6.6 SFL's decision on the cause for any such defects is final and binding.
- 6.7 SFL will not be responsible for failure of Goods supplied which are manufactured to the print, design, technical specification of the Buyer or sample/prototype approved by Buyer and/or any process or processes prescribed by Buyer.
- 7. LIMITATION OF LIABILITY**  
SFL's liability to Buyer, whether in contract, in tort, under any warranty, in negligence or otherwise, shall not exceed in any case the return of the amount of the purchase price paid by Buyer and under no circumstances SFL be liable for special, in direct or consequential damages. The price stated for the Goods is consideration for limiting SFL's liability. No action, regardless of form, arising out of the transactions under the invoice may be brought by Buyer more than one (1) year after the date of the invoice. Without limitation of the foregoing, in no event will SFL be responsible or liable for (a) penalties or penalty clauses of any description, or (b) indemnification of Buyer or others for costs, damages or expenses arising out of or related to the Goods.
- 8. INDEMNIFICATION**  
Buyer shall save and hold SFL harmless from any claims, demands, liabilities, costs, expenses or judgments arising in whole or in part, directly or indirectly, out of breach of obligations, non-compliance any statute/act/rules, negligence, any act or omission, lack of care by Buyer or Buyer's customers, agents, employees or invitees involving the handling, use, possession or resale of the Goods supplied by SFL whether used alone or in combination with other Products. This indemnification shall include all costs, attorney's fees and other expenses paid or incurred by or imposed upon SFL in connection with the defense of any such claim.
- 9. FORCE MAJEURE**  
SFL shall not be liable in any way for any damage, loss, cost or expense arising out of or in connection with any delay, restriction, interference or failure in performing any obligation towards supply or delivery of Goods caused by any circumstance beyond its reasonable control, including, without limitation, acts of God, laws and regulations, administrative measures, orders or decrees of any court, earthquake, flood, fire, explosion, war, terrorism, riot, sabotage, accident, epidemic, strike, lockout, slowdown, labour disturbances, geo-political events, business exigencies, difficulty in obtaining necessary labour or raw materials, lack of or failure of transportation, breakdown of plant or essential machinery, emergency repair or maintenance, breakdown or shortage of utilities, delay in delivery or defects in Goods supplied by suppliers or subcontractors ("Force Majeure"). Any failure in performing any obligations shall not entitle the Buyer to cancel the Order.
- 10. INTELLECTUAL PROPERTY RIGHTS**
- 10.1 The sale of Goods to Buyer shall not, by implication or otherwise, convey any license or intellectual property right relating to the Goods to Buyer.
- 10.2 When Goods are manufactured to Buyer's drawings and/or specifications, the responsibility to ensure that these do not result in infringement of any patent or trademark will lie entirely with the Buyer concerned and the Buyer will be solely responsible for the consequence in case of any such infringement.
- 10.3 SFL owns and retains all right, title and interest in and to any patents, copyrights, mask works, trade secrets, trademarks and other intellectual property rights in and to the Goods. The Buyer is not permitted to use any SFL's trademark, logo or trade name in its letter head, business cards, printed materials, business communication letters or in connection with any Goods, other than with respect to resale of Goods pre-marked or packaged by or on behalf of SFL without prior written consent of SFL.
- 10.4 SFL shall not be liable for any loss or damage for infringement of Intellectual Property Rights.
- 11. CONFIDENTIALITY**  
All information disclosed by SFL which is either expressly identified as confidential or by its nature is implicitly confidential will be kept in strict confidence by the Buyer and not used by the Buyer.
- 12. APPLICABLE LAW, JURISDICTION & ARBITRATION**
- 12.1 Any dispute which may arise from and for any Goods supplied to Buyer shall be governed by the Indian laws and subject to the exclusive jurisdiction of the Courts at Chennai.
- 12.2 Any dispute in connection with or arising between the parties fail to amicably resolve shall be referred to arbitration of a sole arbitrator to be appointed jointly by the parties in accordance with the Indian Arbitration and Conciliation Act, 1996 or statutory modification or enactment thereof. The award of the arbitrator shall be final and binding on the Parties. The place of arbitration shall be Chennai, India, and the language of arbitration proceedings shall be English. Each party irrevocably and unconditionally submits to the jurisdiction of the Courts in Chennai, India, alone to determine any question that may arise other than a matter as provided for hereinabove.
- 13. MISCELLANEOUS**
- 13.1 All notices or documents addressed to the Buyer shall be deemed to have been validly served if delivered at/or sent by post to their last known address. SFL will not be responsible for any demurrage etc., on consignment due to public holidays, postal delays, etc. or any other reasons beyond SFL's control.
- 13.2 In case the Buyer fails to make payment on or before Due Date, the Buyer shall be fully responsible for all the consequential losses to SFL including loss of Goods, interest, freight, taxes, duties and any other charges required to be borne by SFL.
- 13.3 If the Buyer fails to make the payment when it becomes due or if there is any breach by the Buyer of any terms and conditions, SFL may without prejudice to the other rights or remedies cancel this order forthwith or refuse to make further deliveries; in which SFL shall not be held responsible in anyway.
- 13.4 SFL shall have lien on the Goods delivered/supplied to the Buyer as to the unpaid purchase price of Goods (whether in possession or not in possession) and SFL shall be entitled to exercise the lien to recover the unpaid purchase price by taking back the Goods and shall be entitled to sell the same to any other Buyer and adjust the sum so realised against the unpaid purchase price without prejudice to SFL's other rights and remedies to recover the outstanding dues and/or other dues.
- 13.5 SFL reserves its right to appropriate and adjust any sums due to the Buyer against any dues recoverable from the Buyer including delayed payment charges, if any.
- 13.6 The rights and liabilities are not assignable by Buyer in whole or part without prior written consent of SFL.
- 13.7 Any provision hereof prohibited by law shall be ineffective to the extent of such prohibition and without invalidating the remaining provision hereof.
- 13.8 No waiver by SFL of a breach of any provision hereof shall constitute a waiver of any other breach of such provision or any other provision.
- 13.9 Buyer shall be responsible for compliances of law as applicable.
- 13.10 The price mentioned in the Invoice supersedes the list circulated and all the previous price lists and any other price communication.
- 13.11 The prices are for Zinc phosphate, Trivalent (Chrome free) Finish.
- 13.12 The Buyer will adhere to the minimum ordering quantities, i.e. standard packing.
- 13.13 Revision in price if any will be intimated from time to time in the form of Sales Bulletins.

## SFL Retail Claim Policy 2026-27

1<sup>st</sup> April 2026

This Claim Policy document provides the guidelines on reporting the discrepancy claims by SFL Retail Customers for the goods dispatched from SFL Plants across India

Claim Types – The below are the various types of problems for which a customer can register a formal complaint

- Consignment not received (A)
- Partial Consignment received (B)
- Secondary Carton Shortage (C)
- Open Box Receipt (D)
- Quantity Shortage (E)
- Invoice / LR Not received (F)
- Wrong Consignment Received (H)

### **CLAIM LODGING PROCESS:**

**Process for Lodging Discrepancy Complaints** – The complaints can be lodged in the prescribed complaint format provided by SFL. The claim sheet can be either scanned or emailed as an excel sheet to the earmarked SFL Claim Desk and the respective Marketing personnel at SFL.

**Timeline for Registering Complaints** – All complaints need to be lodged in the prescribed complaint format within 15 days from receipt of material since all consignments are door delivered at customer end by SFL, which is mandatory as per GST Norms. If any claims are lodged after the stipulated days specified above claims will not be processed.

### **CLAIM SETTLEMENT PROCESS:**

#### **Short/Excess Receipt complaints:**

- The first step in order to start the claims process is to register a complaint in the format provided. (refer annexure A)
- Customer should compulsorily provide their Unique Claim reference number for every claim reported to SFL
- **\*\*Customer should compulsorily provide the photos of the DA labels pasted on the Master Cartons/ MRP Labels pasted on the Primary Cartons without which claims will not be processed**
- Within 7 working days, SFL will respond back to the customer on whether the claim has been accepted or rejected with valid proof
- For Claims accepted , SFL will register the claim as appropriate shortage and to raise an invoice on the excess receipt materials if any reported by the customer and the **Claim registration**



number (CMR/MRN No.) and excess claim order acknowledgement will be notified to the customer

- **\*\*In case of Wrong / Excess receipt reported by the customer, customer has the option to notify the acceptance of wrong / excess receipt parts.**
- **\*\*Customer has the option to return the wrong/excess received parts, by notifying the return in SFL Claim Format**
- **\*\*Customer need to return materials only to the concerned SFL Plant from where supplies were received by them**
- **\*\*Materials to be despatched on Door Delivery mode only on “To Pay” basis through the same SFL Transporter through whom they had received the supplies**
- **\*\*Debit Note/Invoice raised by them on the respective SFL Plant should accompany the materials**
- **\*\*Materials should strictly accompany with valid e way bills as per GST Norms which is mandatory**
- **\*\*Customer should share the Debit Note/Invoice copy raised on SFL by duly sharing the same in soft form to SFL Claims Desk along with the duly filled in Claim Form**
- **\*\*In the absence of valid Debit Note/Invoice on SFL, SFL will not entertain the settlement of credit notes for the short supplied materials**
- An unique complaint reference number (MRN No.) will be communicated to the customer within 3 working days upon receipt of the materials into SFL Plant along with the copies of the debit note/invoice copy of the returned material if any raised on SFL
- SFL will communicate the Credit Note Details and excess claim invoice details (in case of excess reported ) within 15 working days to the customer

#### **Material Returns:**

- **\*\*Any materials returned by the customer should be notified to SFL Area Executive/Manager & HO and obtain their approval and then register the same in the complaint format provided. (refer annexure A)**
- **\*\*In the absence of non approval from the SFL Area Executive/Manager & HO, SFL will not entertain any claim settlements against the material returns**
- SFL will respond to the customer duly authorizing the material returns only in case of valid reason for material return provided by the customer
- **\*\*Customer need to return materials only to the concerned SFL Plant from where supplies were received by them**
- **\*\*Materials to be despatched on Door Delivery mode only on “To Pay” basis through the same SFL Transporter through whom they had received the supplies**
- **\*\*Debit Note/Invoice raised by them on the respective SFL Plant should accompany the materials**
- **\*\*Materials should strictly accompany with valid e way bills as per GST Norms which is mandatory**



- **\*\*Customer should share the Debit Note/Invoice copy raised on SFL by duly sharing the same in soft form to SFL Claims Desk along with the duly filled in Claim Form**
- **\*\*In the absence of valid Debit Note/Invoice on SFL, SFL will not entertain the settlement of credit notes for the short supplied materials**
- An unique complaint reference number (MRN No.) will be communicated to the customer within 3 working days upon receipt of the materials into SFL Plant along with the copies of the debit note/invoice copy of the returned material if any raised on SFL
- SFL will communicate the Credit Note Details and excess claim invoice details (in case of excess reported ) within 15 working days to the customer

#### **Documentation Requirements for Type of Complaints:**

Customer need to provide different types of documentation required for each claim type to facilitate smooth registration and settlement of the claims

- Consignment not received (A) – Complaint through Mail reporting non receipt of consignments against specific invoice/LR is sufficient
- **\*\*Partial Consignment received (B) – While taking consignment delivery customer should write the number of boxes received on the LR Copy duly signed and stamped by the customer.**
- **\*\*Secondary Carton Shortage (C) – Complaint sufficient. Customer to indicate if the cartons were received in open / damaged condition. It is mandatory to provide the photo of the carton boxes received in open/damaged condition**
- **\*\*Open Box Receipt (D) Customer should write open boxes and number of short boxes on front of the LR Copy. It is mandatory to provide the photo of the carton boxes received in open/damaged condition**
- **\*\*Secondary Carton inner quantity Shortage (E) – It is mandatory to provide the photo of the Primary/Secondary carton boxes received which has short materials**
- Invoice / LR Not received (F) – Complaint Sufficient
- **\*\*\*Wrong Consignment Received (H) – Complaint Required. Customer should compulsorily either refuse accepting the wrongly received consignments at the time of delivery being attempted by the transporter or can notify SFL Claims Desk on Wrong Consignment receipt by providing a photo of the labels pasted on the Master cartons for which SFL will organize pick up of wrongly delivered consignment. In any case customer should not absorb/inward the wrongly delivered consignment and should inform SFL by lodging complaint with SFL Claims Desk**
